Becky circulated these three designs as possible choices for our LAPASSAR pin. We would use this design for pins to sell to fundraise as well as on stationery sent from the Pennsylvania Society. The flower is a mountain laurel.

Single or multiple flowers inside an oval with red, white, and blue in an outer oval with *Pennsylvania* inscribed in background gold or light green. If not red, white, and blue, could have crystals around the outer edge. Another alternative is a round design.

Roz Ashmun volunteered to check her DAR pins to make certain that we are not duplicating a design that has already been used. Some ladies questioned the color in these pictures since mountain laurels are generally white with pink flecks.

Becky has contacted Pamela Wright for prices. Hopefully, we can raise funds at 2021, 2022, 2023, and 2024 Congresses as well as other functions.

Please let Becky know your preferences ([beckymoyerlapassar@gmail.com](mailto:beckymoyerlapassar@gmail.com)) for the design. She will need to acquire approval from the 2024 Congress Committee, an action questioned by some of the ladies. Becky report attending her first planning meeting for the Congress Committee on February 22<sup>nd</sup>. She has agreed to complete the following tasks: forward to attendees sketches of the image for tee-shirts and other items; forward also sketches of the mountain laurel that will be constructed as pins and/or broaches once completed; research emblem/image to be placed on golf shirts and forward that to the committee for consideration.

Becky also relayed the Board's discussion of tee and golf shirts. Again, once the artist furnishes designs, Becky will report back to LAPASSAR members as well as the Congress Committee which will provide seed money for the project. Approval from them may be a requirement for granting of this seed money. Since tee-shirts will be advanced order, LAPASSAR would not have to provide funds from its budget. Golf shirts will have an embroidered patch; these shirts cannot be advanced ordered. Again, the Congress Committee is willing to provide seed money. For each shirt ordered, LAPASSAR would have a return of \$10.00 in commission (perhaps more since this issue is still being negotiated. The artist, Tony Moreschi (website <http://tonymoreschi.com/>) also produces prints and for these, LAPASSAR would receive at least \$15.00 in commission). He may also be able to produce decals and coffee cups for those on a budget. Becky stated that the tee-shirts are ink printed and have a soft and luxurious feel. We pay no sales tax, and the artist can mail the products so that purchasers are not burdened with transportation or postage. The golf shirts may have a keystone and/or a Continental soldier embroidered.

## Bylaw Additions

Jan presented two proposed by-law additions to Article VII—Duties of Elected Officers, Sections 2 and 5. They are presented here for your consideration; then Becky will follow voting protocol to vote by unanimous consent.

Section 2- **The First Vice-President** shall be the Administrative Assistant to the President. She will act as presiding officer in the absence of the President. She shall maintain a current record of the membership of the LAPASSAR. She shall supervise membership activities for LAPASSAR and promote membership to all ladies attending PASSAR events.

### Proposed change marked with highlighting

**The First Vice-President** shall be the Administrative Assistant to the President. She will act as presiding officer in the absence of the President. She shall maintain a current record of the membership of LAPASSAR and, **with the Treasurer, she shall process member applications.** She shall supervise membership activities for LAPASSAR and promote membership to all the ladies attending PASSAR events.

Section 5-**The Treasurer** shall collect and receive all monies due the LAPASSAR. The funds shall be kept in a checking account and/or a savings account as directed by the Board of Directors. She shall pay approved bills and shall keep full and accurate accounts of receipts and disbursements and make a financial report at each meeting of the membership of the LAPASSAR, and at the Board of Directors meetings.

### Added paragraph marked with highlighting

**The Treasurer** is responsible for submitting a 990N-postcard electronically **no later than May 15 for the fiscal year ending December 31 of the previous year to ensure** LAPASSAR's continued 501(c)(3) non-profit status. She is required to save an electronic copy and submit it to the President as well as a print hard copy for LAPASSAR files. The 990N postcard form and instructions are available at <https://www.irs.gov/charities-non-profits/annual-electronic-filing-requirement-for-small-exempt-organizations-form-990-n-e-postcard>

Maribeth offered one suggestion that “The Treasurer” in the added text be capitalized from “The treasurer” in the original text for consistency.

Jan acknowledged the good work of the by-laws committee, and especially Becky and Maribeth in updating bylaws from November 20, 2016. New ones are filed under Bylaws and dated December 14, 2020 on the Ladies Auxiliary link at [passar.org](http://passar.org).

Becky shared the customary practice of transporting a state basket to the host Congress ladies auxiliary to either bid on or raffle. Proceeds from basket defray costs of maintaining the Congress hospitality room, including coffee and goodies available. Becky, Maribeth and Jan will fly to Congress making transport of the baskets difficult. In discussions of the Board (Feb. 5 and 12), members suggested donating a check for \$50.00 rather than the basket itself. Pat McKim wondered how the Board determined the \$50.00 as a suitable amount, and Becky suggested that sum was the best estimate of what items in the basket would cost to include,


